## You will learn how to:

- implement profession standards and expectations relating to the beauty workplace including all relevant health, safety and hygiene obligations.
- undertake a full consultation with clients, build client rapport and perform an in-depth need analysis for beauty services and product needs to develop a beauty treatment plan.
- apply knowledge of natural nail services, facial and skincare services, manual hair removal and body care services.
- perform facial and skin care services.
- perform manual hair removal and body care services.
- apply knowledge of relevant aspects of chemistry, physics and biology in a beauty services context to provide effective services and ensure client comfort and safety.
- provide nutritional advice specific to the skin which is complementary for healthy skin, hair and nails.
- apply knowledge of skin and skin-related disease and disorders to identify symptoms and advise clients' of possible implications in terms of proposed beauty services.
- provide reception and client sales services and carry

out associated transactions and administration.

- contribute to the operation of a small beauty sector business or client base.

## Courses

CBT4.001

### Business and Ethics

This course provides students with the knowledge and be able to understand the workings of small business practice. Students will gain knowledge to develop the personal, professional and ethical behaviour expected by the beauty therapy industry. Students will also gain essential first aid skills and an understanding of the importance of Health and Safety regulations, together with an informed awareness of their role in ensuring that health and safety procedures are implemented and practised within their working environment

CBT4.002

### Consultation and Customer Service

This course aims to provide students with knowledge to undertake a client consultation, perform an in-depth skin analysis and develop a beauty treatment plan. Students will also be able to perform reception duties, including client sales, booking appointments, answering the telephone and updating client details.

CBT4.003

### Nutrition and Nails

This course provides students with the knowledge of natural nail services, gel nails, products and tools to meet clients' needs and industry standards. They will also have the knowledge of nutritional advice specific to the health of hair, skin and nails.

CBT4.004

### Chemistry, Physics and Biology

This course aims to provide students with an

understanding of chemistry, physics and biology relevant in beauty services. An understanding of the integumentary system in terms of its structure, function, disorders and diseases. Students will develop the skills to advise and refer clients for medical advice.

CBT4.005

## Cosmetic Services

This course aims to provide students with the ability to competently perform cosmetic services including application of makeup, eyebrow shaping and eyebrow and eyelash tinting.

CBT4.006

## Facial Therapy

This course aims to provide students with the ability to competently perform facial treatments.

CBT4.007

## Depilation

This course aims to provide students with the skills and knowledge to competently perform depilatory waxing services.

---

CBT4.008

## Body Treatments

This course aims to provide students with the ability to competently perform 'Partial' and/or 'Full Body' tan applications, to gain knowledge of preparing the skin for a spray tan and the products applied to the skin before, during and after a tan service. Students will be able to advise clients on 'at home' spray tanning maintenance. Students will also learn the skills and knowledge required to competently perform body massage.

## Programme Specific Information

### Entry Criteria

#### Academic Entry Criteria

- NCEA Level 2 including Level 1 literacy and numeracy with at least 12 credits in Level 1 science; or
- Equivalent NZQF standards; or
- NZ Certificate in Makeup and Skincare (Introduction) (Level 3); or
- Equivalent knowledge, skills, work experience or study; or
- WITT New Zealand Certificate in Foundation Skills (Level 2) with CFS2.108 Health Careers Pathway (Human Biology) and achievement standard 91101.

#### Life skills / Work experience Entry Criteria

- Evidence of equivalent knowledge and skills gained through relevant life skills or work experience; or
- Evidence of other study (formal or informal) at a level that demonstrates the potential to succeed at Level 4 of this programme.

### Programme length

This is a one-year full-time programme of study, or equivalent part-time

### Class times

Programme is delivered three days per week, one late night per week scheduled in 2nd half of the Programme.

### Assessments

This programme includes competency-based assignments, theory tests and practical assessments.

### Work Experience

This programme has no requirement for work experience, but students are recommended to undertake work experience to enhance their formal learning.

## \*International Fee Exclusions
